With reference to the above and in furtherance to our intimation dated April 16, 2025, we wish to inform you that, based on Board Resolution dated April, 24, 2025 received from Laxmi Dental Lab USA INC ("Foreign Material Subsidiary"), the Company has been allotted 10,000 (Ten Thousand) equity shares of USD 100 (United States Dollar One Hundred) each at par, fully paid up, against the payment of subscription money of USD 10,00,000 (INR 8.57 Crores) by the Company, thereby resulting into increase of shareholding of the Company from 55.56% to 71.43% in Laxmi Dental Lab USA INC.

With the aforesaid allotment of shares to the Company, the transaction stipulated under the Investment Agreement has been completed.
