- I. The name of the Company is LAXMI DENTAL LIMITED\*\$
- II. The Registered Office of the Company will be situated in the State of Maharashtra, i.e within the jurisdiction of Registrar of Companies, Maharashtra at Mumbai.

III. The objects for which the Company is established are:

any secret or other information as to any invention which may seem capable of being used for any of the purpose of the company and to use, exercise, develop or grant licenses in respect of or otherwise turn to account the property, rights or information so acquired.

- 8. To employ experts to investigate and examine into the condition, prospects, value, character and circumstance of business concerns and undertakings of any assets, property of rights.
- 9. To establish branches or appoint agencies, for or in connection with any of the objects of the company.
- 10. To adopt such means of making known the products of the company as may seem expedient and in particular by advertising in the press by circulars by purchase and exhibition of works of art or interest by publication of books and periodicals and by granting prizes, rewards and donations.
- 11.
